Property owners, ratepayers, and other interested parties in or served or to be served by the sewerage system of the Lake Monroe Division of the South Central Regional Sewer District are hereby notified that a public hearing will be held on Ordinance No. 112, amending Ordinance No. 1 to adjust rates.

PROVIDES IN PART AS FOLLOWS:

AN ORDINANCE TO AMEND ORDINANCE NO. 1 FOR THE LAKE MONROE DIVISION (Rate Adjustment)

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF
THE SOUTH CENTRAL REGIONAL SEWER DISTRICT THAT:

Section 7 of Ordinance No. 1 is hereby amended and restated as follows:

Section 7 Sewer Rates.

(a) The amount of sewer rates shall be based upon the quantity of water used on or in the property or premises subject to said rates or charges, as the same is measured by the water meter there in use, except as hereinafter otherwise provided.

(b) Effective with the service period commencing on or around September 1, 2026, to be billed on or around October 1, 2026, the schedule by which the amount of said rates and charges shall be determined is as follows:

METERED WATER QUANTITIES PER MONTH

Up to and including 2,000 gallons: \$47.03 minimum charge per month
Per 1,000 gallons: \$ 6.87 per 1,000 gallons per month
